Subject: Opening of CIG Inter-Agency Office in New York City.

1. Pursuant to Supplemental Directive No. 1 to CIG Directive No. 15, the opening of a CIG Inter-Agency Office in New York City, effective 8 January 1947, is announced.
2. The area initially covered by the New York Inter-Agency Office will be that contained within the boundaries of the New York Port Authority, as shown on the attached map, plus Long Island.
3. The New York Office will hereafter be referred to as the New York Inter-Agency Office (New York I.A.O.) and will be governed by, and operated in accordance with the procedures described in Supplemental Directive No. 1 to CIG Directive No. 15.
4. In the exploitation of this field, CIG will be guided by such collection programs as may be promulgated under the authority of the National Intelligence Authority.
5. Representatives of participating agencies are requested to attend a meeting in New York, on 10 January 1947 at 2:30 P.M., to discuss field operations and procedures. This meeting will be held in the Field Coordination Office of the Air Materiel Command, USAAF, Room 1201, 39 Broadway, New York, N.Y. 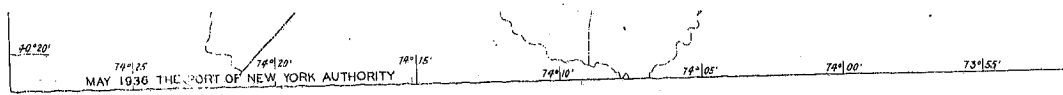

THE PORT OF NEW YORK AUTHORITY MUNICIPALITIES WITHIN THE PORT DISTRICT

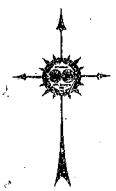
SCALE IN FEET
