

CITATION:

For meritorious service while providing vital and continuous criminal investigative, counterintelligence, and counterterrorism support to the U.S. Navy and Marine Corps, along with allied Coalition Forces throughout the European and Central Command areas of responsibility from 20 August 1990 to 30 September 1991. During Operations DESERT SHIELD and DESERT STORM, assigned personnel of Naval Investigative Service Area Command Europe and Designated Component Units provided superior countersurveillance counterintelligence initiatives, resulting in the arrest deportation of enemy combat forces. Constant liaison with host Nation agencies yielded subsequent reporting of indications and warning of hostile enemy and terrorist actions. As a result of these untiring efforts, U.S. Naval personnel and installations avoided terrorist incidents. Moreover, Naval Investigative Service personnel developed and executed a successful counterintelligence operation against Iraqi forces which resulted in preventing untold allied casualties. By their outstanding display of professionalism, perseverance, and loyal devotion to duty, the officers, enlisted personnel, and civilian employees of the Naval Investigative Service Area Command Europe and Designated Component Units reflected credit upon themselves and upheld the highest traditions of the United States Naval Service.
