# Director's Message . . .



When I first looked at the photos on the front and back covers of this edition of the *Bulletin* showing some of our agents as they looked when they served with other law enforcement agencies, I found it hard to imagine that any of us were ever that young.

There is, without a doubt, something special about having served as a police officer, sheriff's deputy, state trooper, or as a member of any other law enforcement organization which earns those who are a part of it the privilege of being called "cops."

But it does not come without a price.

No one ever said it would be easy. About the same time I joined the City of Berkeley Police Department in 1964, anti-establishment types had coined a new slang name for law enforcement officers. They called us "pigs."

But our counterparts across the bay in the San Francisco Police Department turned the tables on them by using it in a catchy recruiting slogan: "Are you man enough to be a P.I.G.?" It stood for "Pride, Integrity and Guts," and those who qualified could count on \$10,000 a year and all the abuse they could stand. That slogan soon spread to virtually every law enforcement agency in the country. And I am proud to say as I look at our special agent corps that we have plenty of men and women who stepped up and accepted that challenge.


I don't know anyone who went into law enforcement for the money. There are a lot easier and safer ways to make a living -- and with much better hours, too. The hazards are many and they don't just come from the criminal element, either. Daily contact with a public that expects major crimes to be solved in 55 minutes less TV commercial time and is increasingly prone to second-guessing law enforcement officers is also bound to take its toll. It's no wonder why the faces in this magazine have a lot more wrinkles now and, in some cases, a lot less hair!

That is why we need to participate in law enforcement gatherings such as the 102nd Annual Conference of the International Association of Chiefs of Police (IACP), being held in Miami, Florida, October 14-18. It helps strengthen our bonds with local law enforcement agencies whose officers make up that "thin blue line" which protects our streets and neighborhoods 24 hours a day and is the backbone of law enforcement in this country. That is something we should always remember. To do our job, we need the constant support and cooperation of state and local law enforcement agencies.

It also gives us the opportunity to support each other at a time when criticism of our profession is on the rise. Anyone who has searched a dark alley, patrolled a long and deserted strip of highway, or comforted a crime victim's family or friends understands what it is like to be a "cop." To a police officer, the biggest weapon against crime is not a gun or a night stick, but a higher sense of duty and moral purpose. That type of dedication and the sacrifices it requires can best be understood by those who have shared them.

And by sharing those experiences, renewing old acquaintances and making new ones, it does something else, too. It reminds us of something reflected in all those youthful faces on the covers of this book -- our deeply-rooted faith in law enforcement as a noble profession and that despite our human frailties, we are still the "good guys" in whom most people continue to place their trust and hopes for a better, safer world. Our organization is strong and professional because of the background that its members have brought to "the job."

## Many Brought A Heritage of Law Enforcement With Them To NCIS

The "front office" of the Naval Criminal Investigative Service (NCIS) in Washington, D.C., is a long way from the streets and alleys of Baltimore, Maryland, where Thomas W. Fischer began his law enforcement career almost three decades ago.

As Assistant Director for Inspections and Planning, Tom Fischer now lives in a world of starched white shirts, conservative suits, plush carpets, and

furniture made of "real" wood, accompanied by what seems to be an endless barrage of paperwork and administrative problems, all of which require "immediate attention."

It's about as far away from "the street" as a career law enforcement officer can get. But there was a time...

A reminder sits on the bookcase in Fischer's office -- a dark wooden shadowbox with blue felt backing containing his Baltimore Police Department badge and the nine commendations for valor and meritorious service he received while serving

as a patrolman, detective, sergeant and member of the tactical squad.

On the wall is a picture of his 1967 graduation class from the Baltimore Police Academy. "This guy," Fischer said, pointing to a proud, young, smiling face in the photo, "was killed in the line of duty about a week after we graduated."

Having served in another law enforcement agency prior to joining NCIS is a bond which Fischer shares with many NCIS special agents.

It should be emphasized that some of the finest investigators



NCIS has produced began their law enforcement careers with this organization without any previous police experience.

At the same time, however, it is undeniable that those who have prior experience, especially those who served in uniform, have shared in a special experience. And there are a lot of them, including Director Roy D. Nedrow and a majority of the executive staff at Headquarters.

Nedrow began his law enforcement career with the City of Berkeley, California, Police Department, where he served for six years before going on to a career with the U.S. Secret Service and subsequently the NCIS.

As a 21-year-old rookie, Nedrow was chosen as one of the two City of Berkeley police officers who would arrest more than 800 protesters during the highly-publicized civil disturbance on the campus of the University of California at Berkeley in 1964.

"They knew that whoever made the arrests would spend at least the next year in court testifying and they didn't want to tie up any of their experienced officers," Director Nedrow said, referring to his supervisors in the City of Berkeley Police Department. "So they picked two of us who had just graduated from the Police Academy. We alternated making arrests as they brought the protesters in."

In 1984, Nedrow would be reminded of those arrests while he was at an official function attended by then-U.S. Attorney General Edwin Meese. "I remember you. I called your name over 400 times in court," said Meese, who as a young

county attorney prosecuted the Berkeley protesters.

Assistant Director for Criminal Investigations John F. McEleny began his law enforcement career with the Stanton, California, Police Department, while Assistant Director for Counterintelligence David L. Brant began his law enforcement career as a police officer in Dade County, Florida.

Prominently displayed in the office of Assistant Director for Administration Franz Schwarm is a framed copy of the front page of a California newspaper with a large photo of Schwarm

as a patrolman with the City of Berkeley Police Department.

Throughout Headquarters and in virtually every office in the field, some type of memento or reminder of prior law enforcement service can be found in spaces occupied by special agents around the world.

Far from the formality and

frenzy of Washington, D.C., in that world fondly referred to by agents as "the field," Resident Agent in Charge Klain W. Garriga now goes about his duties running the Resident Agency in Little Creek, Virginia.

Three generations of Garriga's family have served in the Gulfport, Mississippi, Police Department. His father, Capt. William P. Garriga, retired from the force in 1979, and Special Agent Garriga's son, Klain W. Garriga II, is now with the department.

Like all others who have prior law enforcement experience, Garriga has his share of mementos and favorite stories, including a somewhat humorous event which usually starts off with "On a hot summer night in August 1971..."

At the time Garriga was a patrolman in Gulfport, where he worked with another officer, John V. Smith, who would eventually become an NCIS special agent and is now stationed in Sasebo, Japan.

"I was on routine patrol on the west side of Gulfport," Garriga said. "At approximately 1:30 a.m., I discovered that someone had removed a window air conditioning unit from the side of Terry's Lounge on Broad Avenue."

Since there had been numerous burglaries in the area, Garriga called for backup and a supervisor. Within moments, Smith and the shift captain arrived.

"After announcing to any would-be burglars that police were present and they should give up, the shift captain decided Officer Smith and I should enter the building," Garriga recalled.

"Officer Smith insisted on entering the building first, thank God! Before I could get in, Smith had the misfortune of awakening a giant German Shepherd, who had been sleeping inside.

"The dog immediately went on the offensive, treeing Smith on top of the bar, where he remained until the owner arrived and secured the dog," Garriga continued. "It turned out that the air conditioner had been removed by the owner for repair. Afterwards, everyone, except Officer Smith, had a good laugh about his K-9 handling abilities. Then he and I went 10-8 from the scene and resumed routine patrol...in the heat of the night."

While Smith may have had his problems with big dogs, some other NCIS agents are experts when it comes to handling K-9's. One of them is Special Agent Don McBride,

who is now assigned to the Parris Island Resident Agency in Beaufort, South Carolina.

Prior to joining NCIS in 1985, McBride served as a

member of the Virginia Beach Police Department, where he spent a good portion of his career as a K-9 officer working with a mixed malamute and shepherd named Magnum. As a team, the two were involved in several SWAT situations and received numerous awards and accolades.

When McBride joined NCIS, Magnum was retired and allowed to stay with his master.

"I kept Magnum until 1988, when I was transferred to Edzell (Scotland)," McBride said. "Magnum remained in Virginia Beach and lived with a retired couple until his death in 1991 at the age of 14, at which time he was buried in the Virginia Beach Police Department's K-9 cemetery with eight other distinguished K-9's."

Many special agents, like Frank E. Atkinson, who is now assigned to the San Diego Field Office, know the feeling of making stops alone while patrolling long, nearly deserted sections of highway. During his 14 years as a trooper with the Oklahoma Highway Patrol, Atkinson made many such stops.

"During my career as a trooper, I was involved in everything from rounding up loose pigs and cattle from overturned trucks in downtown Tulsa to quelling prison riots," Atkinson said. "I spent one tour in the drivers license bureau giving tests. While I was doing that, I was able to attend college and complete my degree."

In his last assignment as a trooper, Atkinson was a member of a troop that was responsible for patrolling a 100 mile stretch of highway between Oklahoma City and Tulsa, which had been

designated as a drug thoroughfare in the U.S. Drug Enforcement Administration's "Operation Pipeline." In a one-year period, Atkinson's troop was responsible for over 100 drug arrests, the seizure of over 2,000 pounds of drugs and \$1.2 million in cash, and the forfeiture of over 50 vehicles.

Experiences such as these, and the people who share them, have made a definite impact on the way NCIS perceives its relationship with other law enforcement agencies.

Despite dwindling financial resources and declining personnel levels, NCIS has still managed to find funds and people to conduct joint training with local law enforcement agencies.

Field offices routinely notify Headquarters about any law enforcement line of duty death in

their areas so Director Nedrow can send letters of condolences to the fallen officer's family and department.

Every day NCIS special agents work closely with their counterparts throughout the law enforcement community, forging relationships which have been beneficial to all involved.

That was particularly evident in a recent memo sent to Headquarters by Wayne Bailey, Special Agent in Charge of the Norfolk Field Office and a former member of the Statesville, North Carolina, Police Department.

The Newport News, Virginia, Police Department asked the Norfolk Field Office to provide a senior special agent to be a member of its lieutenants selection board.

As with most requests from

its counterparts in law enforcement, NCIS was more than pleased to comply.

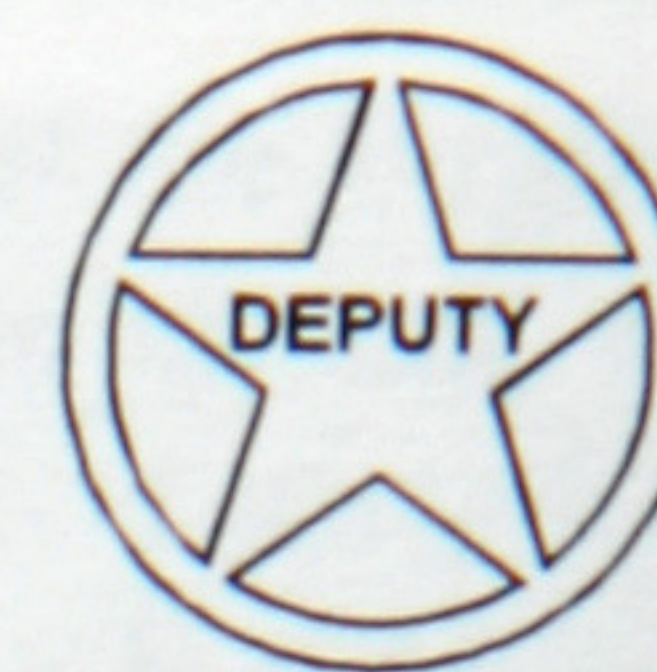
Thanks to all those who took the time to look through old scrap books and files for photos and other information needed for this article.

**ABELAR, HECTOR A. - U.S. Border Patrol** (1976-1986); agent, supervisory patrol agent; served in the San Diego, California, area and was later transferred to the Federal Law Enforcement Training Center, Glynco, Georgia, as a Border Patrol instructor; joined NCIS in 1986; currently assigned to the Kings Bay (Georgia) Resident Agency.

**ADAMS, MIKE A. - South Carolina Highway Patrol** (1979-1986); trooper, trooper first class; stationed in Beaufort County; joined NCIS in 1986; currently assigned to the Gulf Coast Field Office in Pensacola, Florida.

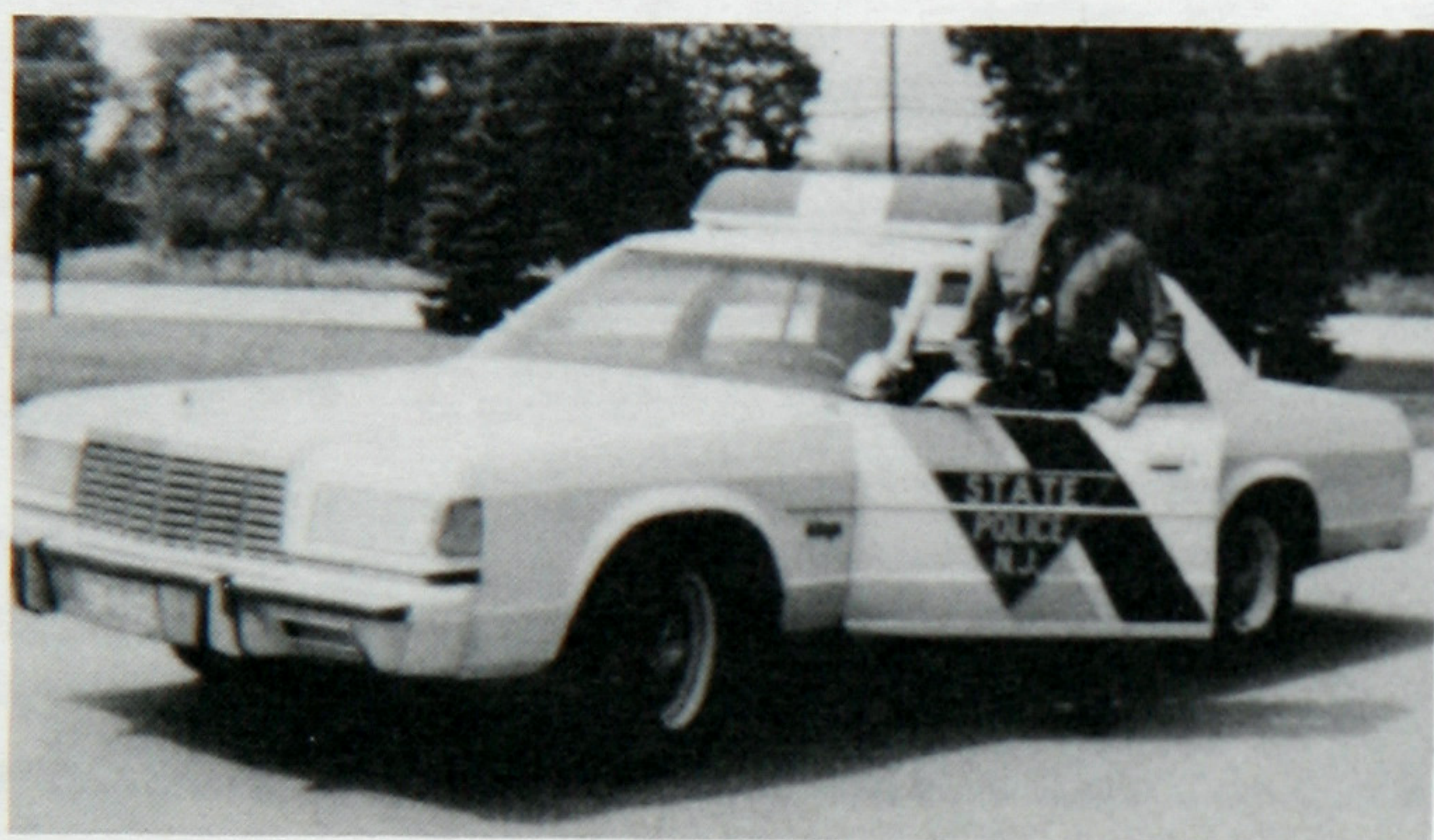

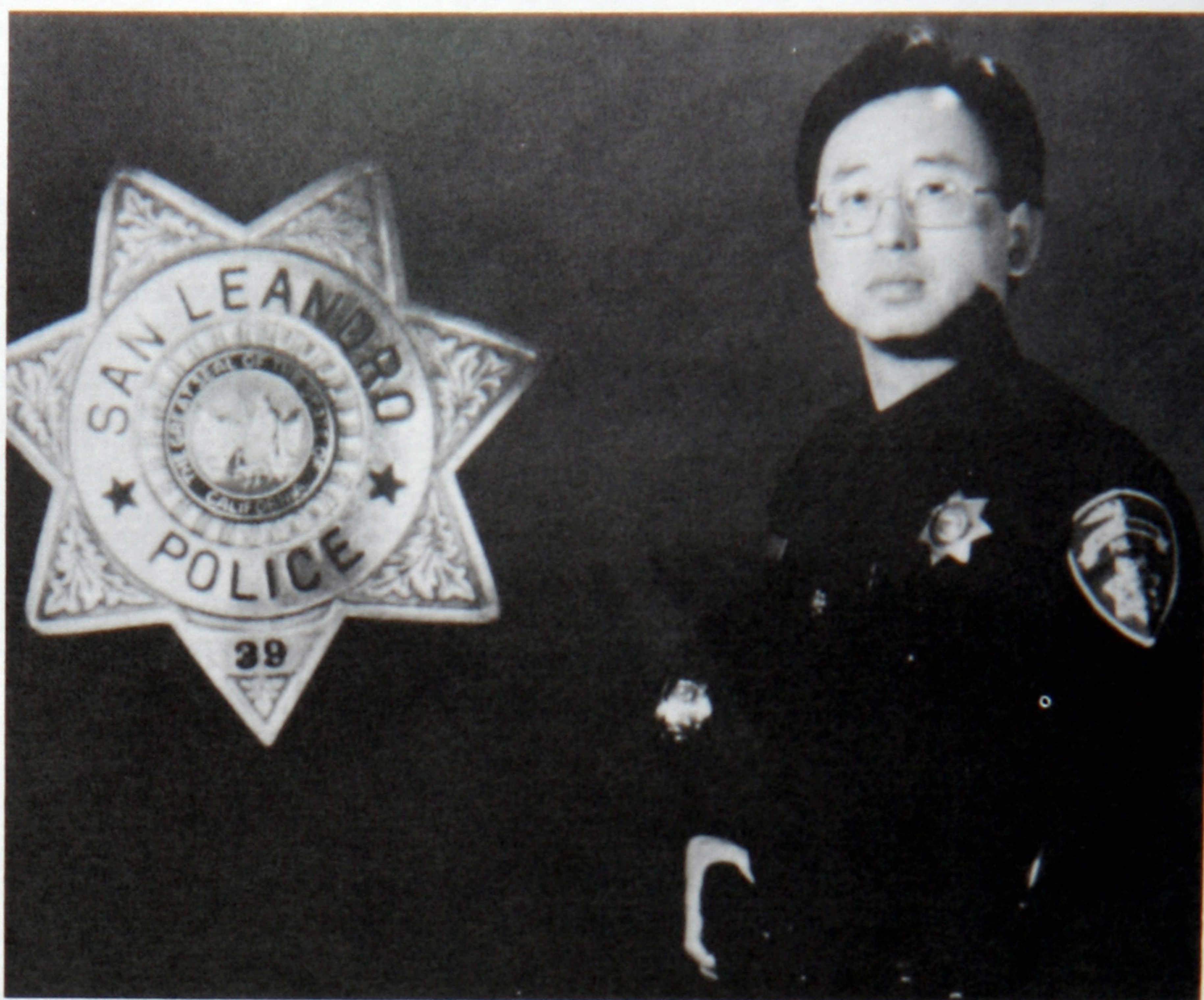
