To be filled out in ink. No erasures. Photo to be cemented on. Fingerprint to be rolled and clear. Bearer to sign partly on photo. Appointing officers to sign in right-hand blank, followed by rank, and on second line give title of office (as "O-in-C, Dist. Intel. Office, 9th N. D.") which signature authenticates all entries. O. N. I. to enter card No., approval of Director, and imprint seal. Seal to be partly on photo and on signature of bearer. Date of expiration may be entered tentatively in pencil as a suggestion, approving official to enter in ink date decided upon. Expired cards to be burned by appointing officer and so reported to O. N. I.

Recipient must obtain renewal as necessary. Any loss or destruction to be reported immediately to holder of custody receipt. THIS CARD IS TO BE USED ONLY IN CONNECTION WITH OFFICIAL BUSINESS. IF USED OTHERWISE, IT IS VOID AND WILL BE WITHDRAWN.



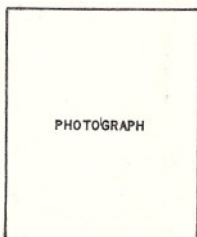

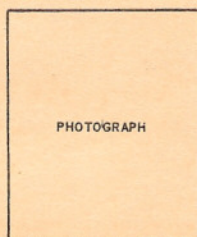

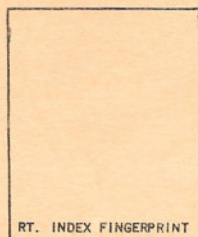
