COMMAND REORGANIZATION SUBJ:

I AM PLEASED TO ANNOUNCE THAT THE VICE CHIEF OF NAVAL OPERATIONS HAS APPROVED A REORGANIZATION OF NSIC. RESULT OF MONTHS OF EFFORT BY A NUMBER OF HEADQUARTERS AND FIELD PERSONNEL AND A MANAGEMENT STUDY OF THE COMMAND ORGANIZATION BY CNO'S OFFICE. THE FOLLOWING ARE THE KEY CHANGES (EFFECTIVE DATE TO BE ANNOUNCED SEPARATELY).

- COMMAND NAME--IN RESPONSE TO WIDESPREAD REQUESTS AND IN DIRECT CONSIDERATION OF THE FACT THAT THE CURRENT COMMAND NAME, NAVAL SECURITY AND INVESTIGATIVE COMMAND (NSIC), IS CONFUSING AND VIRTUALLY UNKNOWN OUTSIDE THE WASHINGTON AREA, THE COMMAND NAME WILL BE CHANGED TO THE NAVAL INVESTIGATIVE SERVICE COMMAND (NISCOM). THE CURRENT USE OF THE NAME "NAVAL INVESTIGATIVE SERVICE" TO IDENTIFY PERSONNEL, NISRU'S, NISRA'S AND NISRO'S WILL REMAIN. THE FOLLOWING CHANGES WILL BE MADE TO THE NAMES OF THE REGIONAL OFFICES:

03HQ - NIS NORTHEAST REGION

05HQ - NIS MID-ATLANTIC REGION

06HQ - NIS SOUTHEAST REGION

11HQ - NIS SOUTHWEST REGION

12HQ - NIS NORTHWEST REGION

20HQ - NIS NATIONAL CAPITAL REGION

60HQ - NIS EUROPEAN REGION

80HQ - NIS MID-PACIFIC REGION

- 81HQ - NIS FAR EAST REGION

83HQ - NIS SOUTHEAST ASIA REGION

- THE SENIOR MANAGEMENT AT HEADQUARTERS HAS BEEN REORGANIZED TO BETTER DISTRIBUTE MANAGEMENT RESPONSIBILITIES, REDUCE THE AMOUNT OF LAYERING AND STREAMLINE THE CHAIN OF COMMAND. THE 02, HERETOFORE KNOWN AS DIRNIS, WILL NOW REPORT DIRECTLY TO THE COMMANDER; HAVE THE TITLE OF DEPUTY COMMANDER FOR OPERATIONS (ADDITIONAL TITLE OF DEPUTY DIRNIS); AND HAVE MANAGEMENT RESPONSIBILITY FOR THE MISSION AND FUNCTIONS RESIDENT IN CODES 21, 22, 23, 25, 26 AND 30. THE 02 WILL CONTINUE TO PROVIDE CONTINUITY OF MANAGEMENT FOR THE COMMAND. THE COMMANDER, NIS COMMAND, WILL HAVE THE ADDITIONAL TITLE OF DIRNIS. THE 01, HERETOFORE KNOWN AS THE DEPUTY COMMANDER, WILL ALSO REPORT 55 DIRECTLY TO THE COMMANDER; HAVE THE TITLE OF DEPUTY COMMANDER FOR E PLANS, POLICY AND SECURITY PROGRAMS; AND HAVE MANAGEMENT RESPONSIBILITY FOR THE MISSION AND FUNCTIONS RESIDENT IN CODES 58 24, 27 AND 29. IN ADDITION, 01 WILL CHAIR THE EXECUTIVE

RESOURCES BOARD, WHICH ALSO INCLUDES 02, 22, 23, 24, 26, 27 AND THE COMPTROLLER, AND WILL RECOMMEND FINANCIAL MANAGEMENT STRATEGY AND CRITICAL FISCAL RELATED DECISION-MAKING FOR THE COMMAND. THE 01 WILL ALSO CHAIR A PERSONNEL TRANSFER REVIEW BOARD WHICH ALSO INCLUDES 02, 00Y, 22, 23, 25, 26 AND THE COMPTROLLER AND WILL REVIEW TRANSFER SLATES PREPARED BY 25. WE ARE PURSUING AN INITIATIVE TO UPGRADE SELECTED HEADQUARTERS DEPARTMENT HEAD BILLETS TO SES RANK.

- AS REQUIRED BY LAW AND REGULATIONS, THE POSITION OF COMPTROLLER WILL BE ESTABLISHED. THE INCUMBENT WILL HAVE MANAGEMENT RESPONSIBILITY FOR THE PLANNING, PROGRAMMING BUDGET SYSTEM AND THE SUPPLY, ACCOUNTING AND BUDGET EXECUTION FUNCTIONS HERETOFORE RESIDENT IN CODE 28. THE COMPTROLLER WILL REPORT TO OO AS REQUIRED BY REGULATION.
 - DEPARTMENT HEADS AT HEADQUARTERS WILL BE RETITLED AS FOLLOWS:
 - EXECUTIVE ASSISTANT DIRECTOR
 - ASSISTANT DIRECTOR FOR INFORMATION AND PERSONNEL SECURITY PROGRAMS
 - ASSISTANT DIRECTOR FOR COUNTERINTELLIGENCE
 - ASSISTANT DIRECTOR FOR CRIMINAL INVESTIGATIONS
 - ASSISTANT DIRECTOR FOR LAW ENFORCEMENT AND PHYSICAL SECURITY PROGRAMS
 - ASSISTANT DIRECTOR FOR CAREER SERVICES
 - ASSISTANT DIRECTOR FOR TECHNICAL SUPPORT
 - ASSISTANT DIRECTOR FOR INFORMATION MANAGEMENT
 - COMPTROLLER
 - ASSISTANT DIRECTOR FOR PERSONNEL SECURITY
 ADJUDICATION AND DIRECTOR, CENTRAL ADJUDICATION
 FACILITY
 - ASSISTANT DIRECTOR FOR TRAINING
- THE FIELD STRUCTURE OF THE COMMAND WILL BE CHANGED AS FOLLOWS: THREE NEW ECHELON THREE COMMAND STAFFS, IDENTIFIED AS NIS LANT AREA, NIS PAC AREA AND NIS EUR AREA, WILL BE CREATED AND STAFFED WITH A COMMANDING OFFICER (CAPT JAGC USN), EXECUTIVE OFFICER (CDR INTEL TAR), AN ADVISOR FOR OPERATIONS (GM-14 SPECIAL AGENT), AND A STAFF COMPRISED OF AN INFO/PERS SECURITY SPECIALIST, LAW ENFORCEMENT/PHYS SEC SPECIALIST AND AN ADMINISTRATIVE SUPPORT UNIT. THE MISSION OF THESE NEW COMMANDS WILL BE TO ENHANCE THE INTERFACE BETWEEN NIS COMMAND AND THE FLEET CINC'S, NOT ONLY IN THE AREA OF THE TRADITIONAL BRIEFINGS ON NIS CRIMINAL INVESTIGATIONS AND COUNTERINTELLIGENCE, BUT ALSO FOR THE FULL SPECTRUM OF FUNCTIONS OF NIS COMMAND. THESE NEW COMMANDS WILL HAVE TASKING AUTHORITY OVER THE NIS REGIONAL OFFICES TO SUPPORT THEIR BRIEFING/INTERFACE RESPONSIBILITIES TO THE CINC'S AND WILL ALSO HAVE A ROLE IN LONG RANGE PLANNING. FURTHER DESCRIPTION OF THE MISSION AND FUNCTIONS OF THESE AREA

COMMANDS WILL FOLLOW SEPARATELY. THE REGIONS, AND THEIR SUBORDINATE COMPONENTS, WILL CONTINUE TO REPORT AND INTERFACE DIRECTLY WITH HEADQUARTERS FOR DAY TO DAY OPERATIONS. THE REGIONAL OFFICES, EXCEPT FOR NIS NATIONAL CAPITAL REGION WHICH WILL REPORT DIRECTLY TO HEADQUARTERS, WILL BE ORGANIZED AS FOLLOWS TO SUPPORT THE FLEET-ORIENTED NIS AREA COMMANDS IN THEIR RESPONSIBILITIES TO THE FLEET CINC'S:

NIS LANT AREA - NIS NE REG, NIS MIDLANT REG AND NIS SE REG.

NIS EUR AREA - NIS EUR REG.

NIS PAC AREA - NIS SW REG, NIS NW REG, NIS MIDPAC REG, NIS

FE REG AND NIS SEA REG.

EXCEPT FOR NIS FE REG AND NIS SEA REG, WHICH WILL BE COMMANDED UNTIL FURTHER NOTICE BY CAPTAINS 1630, ALL NIS REGIONS WILL HEREAFTER BE MANAGED AND DIRECTED BY GM-15 SPECIAL AGENTS WILL HEREAFTER BE MANAGED AND DIRECTORS. EFFORTS ARE UNDERWAY TO IDENTIFIED AS REGIONAL DIRECTORS OF THE LARGER REGIONS TO SES RANK. UPGRADE REGIONAL DIRECTORS OF THE LARGER REGIONS TO SES RANK. ACTION WILL ALSO BE INITIATED TO PROVIDE CIVILIAN ADMINISTRATIVE OFFICERS TO ALL REGIONAL HEADQUARTERS WITHOUT A MILITARY EXECUTIVE OFFICER. IN THE CASE OF NIS EUR, NIS LANT AND NIS PAC, EXECUTIVE OFFICER. IN THE CASE OF NIS EUR, NIS LANT AND NIS PAC, THE CO, XO AND INFO/PERS SEC SPECIALIST BILLETS WILL BE TRANSFERRED FROM THE CO-LOCATED REGIONAL HEADQUARTERS. THIS TRANSFERRED FROM THE CO-LOCATED REGIONAL HEADQUARTERS. THIS UNASSIGNED BILLETS HELD HERE.

- 2. THE UNDER SECRETARY OF THE NAVY AND THE NAVY JUDGE ADVOCATE GENERAL HAVE ALSO APPROVED OUR REQUEST TO CREATE A EILLET ON THE STAFF OF EACH NISRO FOR A LCDR OR SENIOR LT JAGC USN ATTORNEY ADVISOR. THESE ATTORNEYS WILL BE SEPARATE FROM THE NLSO/COMMAND STRUCTURES AND ARE DESIGNED TO PROVIDE "IN-HOUSE" LEGAL COUNSEL TO THE REGIONAL DIRECTOR, HIS STAFF, AND SUBORDINATE RESIDENT—AGENCIES. WE ARE NOW IN THE PROCESS OF BRINGING THESE BILLETS ON LINE.
- 3. NOT ALL THE ABOVE CHANGES WILL OCCUR IN THE IMMEDIATE FUTURE. FOR EXAMPLE, THE FIELD COMMAND STRUCTURE WILL NOT GO INTO EFFECT UNTIL THE SUMMER OF 1989. ALCON WILL BE ADVISED OF THE EFFECTIVE DATE OF ALL CHANGES BY SEPARATE DOCUMENTATION.
