1. Reference (a) approved a proposal by the Director of Naval Intelligence to transfer the remaining personnel of OP-009D to the Naval Investigative Service (NIS) effective 1 July 1974. Eight civilian personnel are affected by this transfer. This is the follow-on to a previous decision, coordinated with CNO (OP-09B), to transfer seven civilian personnel from OP-009D to NIS effective on 23 June 1974. Two mass transfer actions are therefore required to accomplish these changes. This letter is to request you to arrange for the mass transfers involved.
