AGENT'S MANUAL

Additional copies of the ONI Agent's Manual (ONI 63-1A) are available at ONI headquarters. Request needed copies by letter. Incidentally, tentative plans call for revision of the Manual during late FY 1965. All agents are encouraged to begin thinking constructively about any recommended changes in either the format or content of the Manual. More will be forthcoming on this at a later date.

ADMINISTRATION OF AGENT PERSONNEL

Agents' Dependency Data. Not all Districts are complying strictly with Section 1003 of the Manual for Administration - Naval Intelligence Agents (ONI 3820.71) regarding submission of dependency data and changes thereto. This is particularly critical when issuing transfer orders which must reflect data regarding dates of birth of each dependent. In several recent cases absence of up-to-date information in Op-923 records has necessitated TWX queries of the DIO's.

Oath of Office of Agent Personnel. Administration of the oath of office to agent personnel is no longer required nor desired. Do not submit the signed forms attesting that this oath has been administered to ONI (Op-923).

Submission of Social Security Numbers for New Hires. The Social Security number of each newly hired agent must be submitted along with other requisite data immediately.

TRAINING NOTES

Included in the concept of the ONI Agents' Basic Training Course is the premise that each agent attending the course (the great majority of whom have been aboard in excess of six months or much longer) will have an intimate working knowledge of the contents of the Agent's Manual (ONI 63-1A). It has been our regrettable experience that this is an invalid premise. Agent supervisory personnel should encourage all agents to gain and retain this knowledge by study and re-study of the Manual. The practical realities of the problems of production in the field are well understood at Headquarters; however, we must constantly strive to maintain the proper balance between quantitative and qualitative production. One of the best ways to ensure this is by ensuring that each agent rapidly acquires a thorough knowledge of the Manual.

Strictly from the standpoint of administration of the training program, it is apparent that when a small number of agents do not have this knowledge upon reporting to the basic training course, the level of instruction must be lowered for their benefit and thus penalize the remainder of the class.

Polygraph Training. The following agents satisfactorily completed the ONI Agents' Polygraph Training Course (1P-64) on 14 February 1964 and each was issued a letter of authorization by DNI to conduct polygraph examinations.

Use of the Polygraph. As evidenced by agents attending the Basic Training Courses and those taking examinations for advancement, there is an apparent continuing misunderstanding of an important policy regarding administration of polygraph examinations. All agents are advised to thoroughly familiarize themselves with Section 3-2103 of the Agent's Manual, with particular emphasis on Section 3.2103.3(f). *Revised 5/6/64 LRZ*

HAZARDOUS DUTY

A Southern newspaper recently carried a photograph demonstrating that not all of the hazards of the agent profession can be characterized in the fashion of the gunplay of the old West. The photograph depicted a fifty-five year old swinging bridge spanning Licking River which had been recently washed away during a rise in the river. S/A Ken JONES, the R/A at Lexington, Kentucky, reported that he had had a reference living at the other end of one of those bridges on his last road trip to Eastern Kentucky. It appears this hazard will have to rank just behind that of moonshiners mistaking us for revenooers in those parts.

NOTICES AND INSTRUCTIONS

The following Notice and Instruction are among those recently published of interest to agents in the field:

ONI NOTICE 5520 of 25 February 1964, Subj: Nuclear Weapons Reliability Program; Background Investigations of Personnel Assigned to (Advised of priority and due dates for subject investigations)

BUWEPS INSTRUCTION 8370.1, Subj: Lost or Stolen Small Arms; reporting of (Directs commands concerned to prepare individual letter reports of loss or theft of small arms to (1) local police (civil and military), (2) the DIO, and (3) DNI. The latter will be responsible for forwarding these reports, as appropriate, to the FBI for inclusion in the National Stolen Property Files and/or to the Alcohol and Tobacco Tax Division, IRS.)

TERRITORIAL BOUNDARIES WITHIN DISTRICTS

Changes in workload with attendant personnel changes cause realignment of FIO and RA territorial boundaries from time to time. ONI INSTRUCTION 5213.13 requires notification of such changes to ONI and other DIO's as occurring. This requirement is frequently overlooked.

COMPENSATORY LEAVE

Many questions have arisen during recent Basic Training Courses concerning ONI's policy with respect to compensatory leave, or "comp time" as it is familiarly called. The ONI policy is clearly stated in Section 5011 of the Manual for Administration - Naval Intelligence Agents. Attention is invited to the last sentence of that section, "Generally, the purpose of the time off is to provide a period of recuperation for an agent immediately following a lengthy period of continuous operations which have interfered with his normal hours of rest and relaxation." For example, it is visualized that agents working until the early morning hours on a surveillance will, if possible, be authorized sufficient "comp time" the next day in order to facilitate their recuperation. Or, following a lengthy, arduous investigation in which the agent worked many long and unusual hours, isn't it a reasonable application of this policy that the Supervising Agent grant him a day off to renew his acquaintance with his family? Each of you can think of many justifiable examples. As a practical matter, it is well understood and appreciated at headquarters that a significant percentage of our agents work many over-time hours for which they will never be recompensed except by the professional satisfaction derived from performing a difficult, important job well.

NISG BULLETIN DISCONTINUED

The 31 December 1963 issue of the Newsletter reported organizational changes resulting from the disestablishment of the NISG concept. During the time NISG was active, four issues of the NAVINVSUPPGRU BULLETIN were published. Hereafter material of the type formerly printed in the BULLETIN will be disseminated in the Newsletter or by other means.

COORDINATION

The U. S. Naval Counterintelligence Support components are under the military command of named fleet units, including subordinate elements. Many of these commands have on their staffs an ACOS (Intelligence), or a N-2. It is vitally important for the OINC of the NAVCINTSUPP components to coordinate fully with the cognizant ACOS (Intelligence) or the N-2, and such coordination should include the field of investigation. "Teamwork" is the key to successful N-2/NAVCINTSUPP performance.

NEW MEMBER OF THE FAMILY

The "Naval Counterintelligence Support" organization continues to grow, with the newest NCISA being located at the U. S. Naval Base, Guantanamo Bay (GTMO), Cuba.
