# DIGNITY AND PRIDE OF ORGANIZATION AND POSITION

A memorandum with subject as above was recently addressed to all agents in a certain District by the DIO. The sentiments expressed in it are certainly endorsed by ONI and it is reprinted here in its entirety as containing a message of value to all agents:

- "1. During my recent visit of inspection to several of my Resident Agencies I found too much reflection of a feeling of timidity and lack of importance, on the part of some of the Special Agents. This tends to deter desired relations with other principal agencies and also fails to obtain access to many preferable sources of information in facilitation of our mission. It is necessary, not only to improve our production, but also to improve our sense of dignity and recognition as the personal representatives of the Chief of Naval Operations (Director of Naval Intelligence) in conformity with the expressed concepts of the high standards of the Director of Naval Intelligence. I want each of you to stand up a little straighter; to, in effect, grow a few inches with pride and confidence in yourselves and your responsibilities. You should earn the same high respect in the community as the leading lawyers, the leading doctors, or other outstanding members of respectable society. You cannot force such respect, nor can such stature be self imposed, but you can so earn this recognition inconspicuously and quietly as you should. I have confidence and respect in each and everyone of you. You must demonstrate that you have the pride and confidence which I know you deserve.
- "2. Again I wish to say, grow with dignity and pride and continue your fine work."

### MAINTENANCE OF RETIREMENT RECORDS

Attention is invited to the fact that the initial submission of the record of investigative assignments of individual agents was required with the April 1959 Qualification and Evaluation Sheets. Several Districts have submitted Evaluation Sheets without the accompanying records. Delinquent Districts are urged to forward these promptly. Section 12004.2 of ONI 70-2 applies.

### NAME CHECKS IN ITALY AND GREECE

ONI has been advised that in order to run name checks on individuals of Italian or Greek extraction in those countries it is necessary to have the birth date of Subject, as well as the names of the father and mother of Subject. This is due to the manner in which the pertinent records are indexed in those countries.

# INVESTIGATIVE COVERAGE IN THE CARIBBEAN AREA

Attention is invited to DIO-10ND serial 54 of 14 March 1958 to all DIOs/IOs which sets forth the areas in which investigative coverage can be furnished within the geographical limits of the TENTH Naval District. Leads are still being received in ONI for forwarding to Naval Attaches which properly should be directed to DIO-10ND. The reverse situation also occurs from time to time.
