b. Mission Statement. The mission statement for the redesignated shore activity is modified as follows:

To maintain, command and operate a world-wide organization to fulfill the investigative and counterintelligence responsibilities of the Department of the Navy (less those combat related counterintelligence activities under the functional responsibility of the Marine Corps); to direct and manage the Department of the Navy Security Program including information, physical and personnel security (less Sensitive Compartmented Information (SCI)) as well as central adjudication for security clearances (less SCI); to direct and manage Navy Law Enforcement and Physical Security; and to perform such other functions and tasks as directed by higher authority.

3. Delegation. The Chief of Naval Operations exercises authority for the redesignated shore activity through:


