- 1. References (a) and (b) are cancelled herewith.
- 2. Enclosure (A) is forwarded for compliance.
- 3. Addresses hereafter will conduct no interviews of foreign intelligence sources for the procurement of Intelligence Report (NNI-96) material except when cleared through, or requested by, the local Central Intelligence Agency field office.
- 4. ONI requests for information from domestic sources of foreign intelligence henceforth will be made through CIA headquarters for transmittal to, and collection by, CIA field offices. In cases of already established DIO sources, CNI may recommend that collection be done by cognizant DIO at the request of the CIA field office manager.
- 5. Pending assignment of naval representatives to duty in CIA field offices, addressees will maintain working liaison with appropriate CIA field offices to insure uninterrupted flow of information from existing Navy sources.
- 6. Addressees shall make available to appropriate CIA field offices for coordination and exploitation all producing sources of foreign intelligence now held by District Intelligence Officers.

- 7. Addressees will be on the alert for domestic sources of such foreign intelligence as falls primarily within the sphere of naval interest and will inform the local CTA field office, or CNI for transmittal to CTA headquarters, whenever such intelligence is available for collection.
- 8. Addressees will inform CNI of all former or prospective sources turned over to CIA under paragraphs 6 and 7 above.
- 9. Addressees will continue to forward to CNI names of potential sources of foreign intelligence (Contact Register entries)
- 10. Implementation of Enclosure (A) is not to be considered as affecting in any way the conduct or performance of counter intelligence programs now in effect.
- ll. Implementation of Enclosure (A) is not to be considered as affecting the direct relationship between addressees and inactive personnel of the Organized and Volunteer Naval or Marine Corps Reserve for training purposes.
- 12. Compliance with Enclosure ( $\Lambda$ ) does not entail any present transfer of DIO personnel or change in DIO organization.
- 13. Addressees are directed to cooperate with CIA field offices to the fullest extent in the implementation of Enclosure (A).
- 14. Transmission by Registered Guard Mail or U. S. Registered Mail is authorized in accordance with Article 76 (15) (e) and (f), U.S. Navy Regulations.
