INVESTIGATION

- 1. Reference (a) reports results of investigation relative to allegations that Subject and Co-Subject, former Prisoners of War in North Vietnam, (Circa 1968-1973), did possibly violate the Code of Conduct, orders issued by the Wing Commander (Fourth Combined POW Wing) and cooperate with the enemy.
- 2. As reflected in reference (a), interviews of 16 former POWs disclosed numerous violations of the Code of Conduct, direct violation of the Wing Commander (LTCOL Robinson RISNER, USAF) orders; known by the codeword "PLUMS" and several instances observed by those interviewed of direct cooperation with the North Vietnamese on the part of Subject and Co-Subject.
- 3. In addition to those interviewed, in reference (a), twenty-three (23) other former POWs were interviewed to date in conjunction with this investigation. In most cases all those interviewed furnished statements that corroborated, and in some instances, furnished additional information, relative to the comments made by those previosuly interviewed concerning the original allegations set forth by the requester (Attachment (1)) and information furnished by those POWs previously interviewed concerning Subject and Co-Subject's behavior during their internment. The date of each interview is reflected parenthetically followed by their respective "shoot down date" indicating the period of time about which each could provide information. For reference, they are listed alphabetically and transcripts/affidavits are listed numerically as attached.
