For information of New York subject is former US Marine Corps enlisted man, who was released to inactive duty on 9/11/59, with obligated service in the Reserve until 12/8/62. In 10/59 subject appeared at US Embassy, Moscow, and stated he desired to renounce his US citizenship and stated he had applied for Soviet citizenship following his entry into Russia from Finland 10/15/59. He received an undesirable discharge from the US Marine Corps Reserve 8/17/60 for reason of unfitness. State Department communication dated 5/17/62 advised that determination had been made that subject is still an American citizen and that both he and his wife had obtained exit permits and State Department had given approval for their travel, accompanied by their infant child to the US.

Bureau liaison was informed by ONI on 6/14/62 that ONI is aware of subject's scheduled arrival in US but has no confirmation of his actual arrival. ONI contemplates no action against subject but requested to be advised of results of our interview. Bulet 5/31/62 instructed Dallas to thoroughly interview subject on his arrival in the US to determine whether he

NOTE: Reairtel advised that according to information received from INS the names of Lee Oswald, Mrs. Marina Oswald, and daughter, June, are included on the advanced manifest for the ship, "SS Maasdam", scheduled to dock Hoboken, New Jersey, 11 a.m. 6/13/62. Dallas has been previously instructed to submit results of interview in form suitable for dissemination. Liaison Supervisor, Fitzgerald obtained information from William Abbott, ONI.
