Enclosure (A) is a copy of an unclassified letter sent by the 1. Federal Bureau of Investigation to all law-enforcement officials, stating that the Federal Bureau of Investigation had been ordered to take charge of investigative work in matters relating to espionage, sabotage and violations of neutrality regulations. This caused some confusion among civil lawenforcement officials as to whether or not to turn over to the Navy and the Army information which was of primary interest to these Services ...

Enclosure (B), prepared by the Federal Bureau of Investigation 2. as a modification of the instructions contained in enclosure (A), has been sent to all Special Agents in Charge of Federal Bureau of Investigation Field Divisions. It will be noted that while enclosure (B) is not addressed to all law-enforcement officials as was done in the case of enclosure (A). Special Agents in Charge of Field Divisions have been directed to bring the bulletin to the attention of all law-enforcement officials in their Districts.

TO ALL LAW ENFORCEMENT OFFICIALS:

For your information, the following formal statement was today issued by the President of the United States:

> "The Attorney General has been requested by me to instruct the Federal Bureau of Investigation of the Department of Justice to take charge of investigative work in matters relating to espionage, sabotage, and violations of the neutrality regulations.

This task must be conducted in a comprehensive and effective manner on a national basis, and all information must be carefully sifted out and correlated in order to avoid confusion and irresponsibility.

To this end I request all police officers, sheriffs, and all other law enforcement officers in the United States promptly to turn over to the nearest representative of the Federal Bureau of Investigation any information obtained by them relating to espionage, counterespionage, sabotage, subversive activities and violations of the neutrality laws."

I am bringing this statement to your attention in order that if you have not already been advised of the President's desires in the handling of cases of the type above enumerated, you may be informed concerning the Federal Government's program. I am confident that you will cooperate in this matter by immediately notifying the nearest representative of the Federal Bureau of Investigation of any information received relating to cases in the above classifications.

(D) WAR AND NAVY DEPARTMENTS INFORMATION. -- It is desired that you bring to the attention of all law enforcement officers in your district through appropriate channels as promptly as possible, the following statement:

Law enforcement officials are encouraged to turn over direct to representatives of the War and Navy Departments information which is of primary interest to those departments. From time to time when law enforcement officers receive information which relates specifically to or is of primary interest to the Military or Naval organizations, they should turn this information over immediately to the nearest officer of the War or Navy Department.

Information that is of primary interest to the War and Navy Departments includes matters pertaining to personnel of those departments, including both uniformed and civilian personnel; subject matter pertaining to the Military and Naval establishments; suspicious or unusual movements or activities of foreign aircraft and shipping, including alien-manned fishing craft and Military and Naval information regarding foreign armies and navies.

The foregoing types of information, even though turned over to representatives of the War and Navy Departments, should also be transmitted to the nearest representative of the Federal Bureau of Investigation.
