THE FOLLOWING TEXT FROM NAVATAC BLUE DART 008-01: TELEPHONE CONTACT WITH NCIS REP AT PENTAGON INDICATES POSSIBLE EXPLOSION/FIRE AT PENTAGON, ARLINGTON, VIRGINIA; CONFIRMED BY CNN.

MULTIPLE ATTACKS WITHIN A LIMITED TIME FRAME CORRESPONDS WITH KNOW AL-QA'IDA TERRORISM TACTICS. THE POSSIBILITY OF ADDITIONAL FOLLOW-ON TERRORIST INCIDENTS CANNOT BE DISCOUNTED. ALL COMMANDS ARE RECOMMENDED TO TAKE APPROPRIATE FORCE PROTECTION ACTION.
